PADA menjalankan kuasa yang diberikan oleh perenggan 252(1)(e) Akta Pengangkutan Awam Darat 2010 [*Akta 715*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pengangkutan Awam Darat (Pengkompunan Kesalahan) (Pindaan) 2013**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada tarikh Peraturan-Peraturan ini disiarkan dalam *Warta*.

2. Peraturan-Peraturan Pengangkutan Awam Darat (Pengkompunan Kesalahan) 2011 [*P.U. (A) 276/2011*] dipinda dalam perenggan 2(a)–

(a) dengan memasukkan selepas perkataan “kesalahan di bawah seksyen” perkataan “121, 122, 123, 124, 125, 126, 127, 129, 131, 133,”;

(b) dengan memasukkan selepas perkataan “22(3),” perkataan “23(2), 30(2), 31(2), 41(3), 42(2),”;

(c) dengan memasukkan selepas perkataan “49(2),” perkataan “57(3), 58(2), 65(2), 66(2),”;

(d) dengan memasukkan selepas perkataan “82(3),” perkataan “128(1), 128(2), 128(3), 128(4),”.

LAND PUBLIC TRANSPORT ACT 2010

LAND PUBLIC TRANSPORT (COMPOUNDING OF OFFENCES) (AMENDMENT)
REGULATIONS 2013

IN exercise of the powers conferred by paragraph 252(1)(e) of the Land Public Transport Act 2010 [*Act 715*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Land Public Transport (Compounding of Offences) (Amendment) Regulations 2013**.

(2) These Regulations come into operation on the date the Regulations are published in the *Gazette*.

Amendment of regulation 2

2. The Land Public Transport (Compounding of Offences) Regulations 2011 [*P.U. (A) 276/2011*] are amended in paragraph 2(a)–

(a) by inserting after the words “offences under sections” the words “121, 122, 123, 124, 125, 126, 127, 129, 131, 133,”;

(b) by inserting after the words “22(3),” the words “23(2), 30(2), 31(2), 41(3), 42(2),”;

(c) by inserting after the words “49(2),” the words “57(3), 58(2), 65(2), 66(2),”; and

(d) by inserting after the words “82(3),” the words “128(1), 128(2), 128(3), 128(4),”.
