LAND PUBLIC TRANSPORT ACT 2010

LAND PUBLIC TRANSPORT (COMPOUNDING OF OFFENCES) (AMENDMENT)
REGULATIONS 2016

IN exercise of the powers conferred by paragraph 252(1)(e) of the Land Public Transport Act 2010 [*Act 715*], the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Land Public Transport (Compounding of Offences) (Amendment) Regulations 2016**.
