KADAR TAMBANG BAHARU BAGI PERKHIDMATAN KENDERAAN PERKHIDMATAN AWAM KELAS TEKSI DAN KERETA SEWA

1. TUJUAN

- 1.1 Pekeliling ini bertujuan untuk memaklumkan tentang kadar tambang baharu bagi perkhidmatan kenderaan perkhidmatan awam kelas teksi (“Teksi”) bagi jenis perkhidmatan Bajet (“Teksi Bajet”) dan teksi 1Malaysia (“TEKS1M”), perkhidmatan kenderaan perkhidmatan awam kelas kereta sewa (“Kereta Sewa”) yang beroperasi di Semenanjung Malaysia dan perkhidmatan Teksi Johor Bahru-Singapura yang beroperasi dari Johor Bahru ke Singapura (“Teksi JB-Singapura”).

2. KADAR TAMBANG BAHARU

- 2.1 Kadar tambang baharu Teksi Bajet, TEKS1M, Kereta Sewa dan Teksi JB-Singapura adalah seperti yang termaktub di dalam Peraturan-Peraturan Pengangkutan Awam Darat [Kaedah-kaedah Kenderaan Motor (Pengangkutan Perdagangan) (Pindaan) 2015] 2015. Salinan Peraturan tersebut adalah seperti di Lampiran 1.

3. ARAHAN-ARAHAN LAIN

- 3.1 Semua pengendali berlesen Teksi Bajet dan TEKS1M perlu mengambil langkah-langkah sewajarnya termasuk menjalani proses

kalibrasi meter Teksi manakala semua pengendali Kereta Sewa dan Teksi JB-Singapura perlu mengemaskini jadual kadar tambang bagi menyelaraskan kadar tambang sedia ada dengan kadar tambang baharu.

- 3.2 Tindakan undang-undang akan diambil bagi mana-mana pengendali yang mengenakan tambang melebihi daripada kadar yang telah ditetapkan.

4. **TARIKH KUATKUASA**

- 4.1 Arahan-arahan dan perkara-perkara yang dinyatakan di dalam pekeliling ini berkuatkuasa mulai 19 Mac 2015.

(PINDAAN) 2015] 2015

PADA menjalankan kuasa yang diberikan oleh perenggan 252(1)(t) Akta Pengangkutan Awam Darat 2010 [Akta 715], Menteri, atas syor Suruhanjaya, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pengangkutan Awam Darat [Kaedah-Kaedah Kenderaan Motor (Pengangkutan Perdagangan) (Pindaan) 2015] 2015**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 19 Mac 2015.

Pindaan Jadual Kelima

2. Kaedah-Kaedah Kenderaan Motor (Pengangkutan Perdagangan) 1959 [L.N. 175/1959] dipinda dalam Jadual Kelima di bawah kepala PART 1 – WEST MALAYSIA berhubung dengan subkepala FARES AND RATES TO BE CHARGED—

(a) dengan menggantikan butiran 12 dengan butiran yang berikut:

“12. The fares to be charged for a taxi cab shall be at the rates as follows:

LAND PUBLIC TRANSPORT ACT 2010

LAND PUBLIC TRANSPORT [MOTOR VEHICLES (COMMERCIAL TRANSPORT)
(AMENDMENT) RULES 2015] REGULATIONS 2015

IN exercise of the powers conferred by paragraph 252(1)(t) of the Land Public Transport Act 2010 [Act 715], the Minister, on the recommendation of the Commission, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Land Public Transport [Motor Vehicles (Commercial Transport) (Amendment) Rules 2015] Regulations 2015**.

(2) These Regulations come into operation on 19 March 2015.

Amendment of Fifth Schedule

2. The Motor Vehicles (Commercial Transport) Rules 1959 [L.N. 175/1959] are amended in the Fifth Schedule under the heading PART I – WEST MALAYSIA in relation to subheading FARES AND RATES TO BE CHARGED—

(a) by substituting for item 12 the following item:

“12. The fares to be charged for a taxi cab shall be at the rates as follows:
