1 INTRODUCTION

This procedure is to provide guideline on the application of Railway Operator's Licence in accordance to Section 101 of Land Public Transport Act 2010.

2 RAILWAY OPERATOR'S LICENCE APPLICATION

- 2.1 The application of Railway Operator's Licence application shall be made not less than 6 months from the tentative date of railway opening or expiry of existing licence. The submission of application shall be made together with submission of the document as per APPENDIX 1 and APPENDIX 2.
- 2.2 APAD may request further evidence or documents which are deemed necessary to support the application and these documents shall be provided within 14 working days or mutually agreed period between APAD and applicant. APAD will proceed with the application upon receipt of all information required for the application from applicant.
- 2.3 Please note that any application for Railway Operator's Licence to operate at newly built railway or extension of current railway shall be made together with application of Railway Opening as required under Section 103 of Land Public Transport Act 2010. Applicant shall factor in the time needed to obtain any necessary safety approvals, railway system verification and certification, trial operation exercise and readiness of operation and maintenance manual.
- 2.4 Application that require the fare approval from Cabinet shall provide financial information, forecast ridership and cost, actual distance between the stations and other information that may require to justify the proposed fare.

3 ELIGIBILITY

- 3.1 The eligible criteria's that must be met by applicant in order to obtain Railway Operator's Licence for operating railway are as follows:
 - a) It is registered with the Companies Commission of Malaysia;
 - b) One of its main object clause in its Memorandum and Articles of Association is to provide land public transport services;
 - c) It has sufficient professionals and competent personnel with expertise and experience related to railway;
 - d) It has a minimum paid-up capital equivalent to or more than its one full year operating cost, or such amount as may be determined by APAD; and
 - e) Agreement that provide legal right to the applicant to access and operate Railway by the Asset Owner and Infra Manager of the Railway Network.



3.2 Applicant should demonstrate professional and competent personnel with knowledge, skill and experience in rail operation and safety to ensure that decisions and tasks are undertaken correctly.

4 FEE PAYMENT

- 4.1 Railway Operator are subject to pay the application fee and annual licence fee as stipulated in Railway Operator's Licence approved by Minister, upon considering the length of network, number of station, rolling stock and other possible cost may be incurred by APAD to perform its duties under Land Public Transport Act 2010.
- 4.2 The amount of fee will be notified to applicant upon issuance of Railway Operator's Licence.
